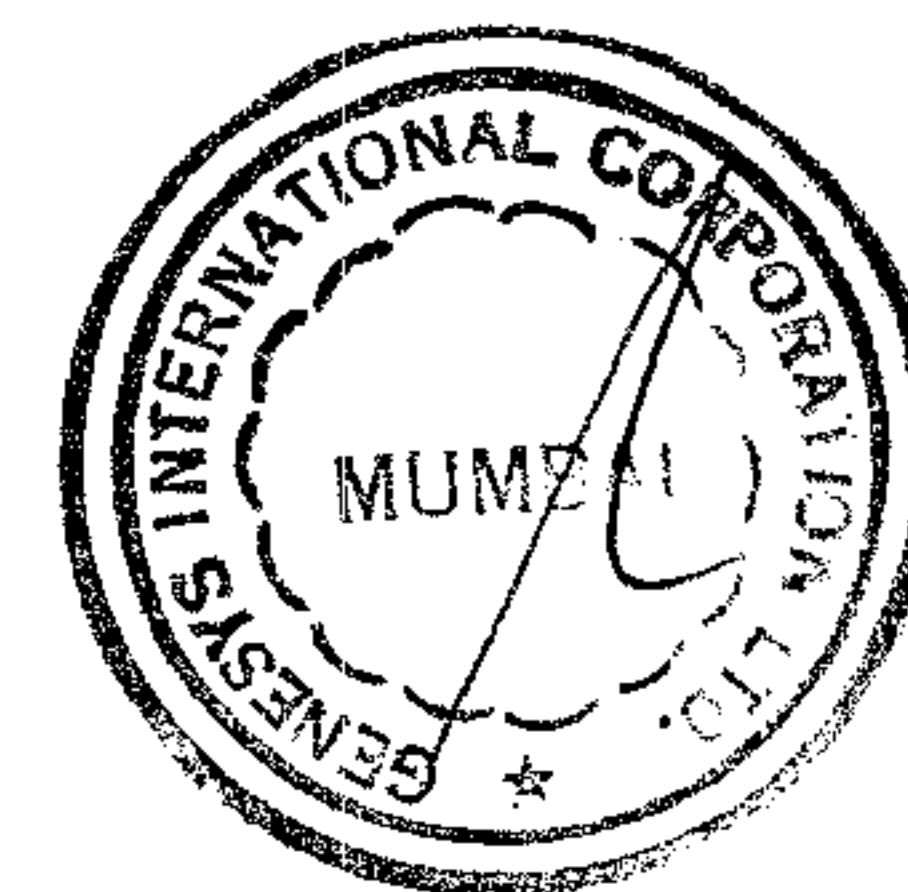

The Board of Directors,


Genesys International Corporation Limited.
